Incidental sampling method was employed for the selection of adolescent girls studying in the standard eleven. 70 adolescent girls students were participated in the study.

### **Tool of the study:**

Researcher has prepared an opinionnaire on adolescent girl harassment through mobile. The opinonnaire was composed of five point Likert scale. The tool was validated from experts.

#### Statistical tool:

Percentage as statistical tool was used to check the opinion of adolescent girl students on harassment through mobile.

## Findings:

1. 27% of adolescent girl students have personal mobile. All these adolescent girls belong to good economical family background. All the adolescent girl students felt that they must have mobile hand set for easy communication.

2. 46% of adolescent girls students felt that mobile is used for the purpose of playing songs to harass girls but only 16% adolescent girls said that they were harass by the playing songs on mobile.

3. Adolescent girl students having mobile doesn't receive any troublesome SMS and miscalls.

4. 74% adolescent girl students admit that mobile is used for taking pictures of girls while 23% adolescent girl students admit that their photo was taken on mobile by boys.

5. 24% adolescent girl students felt that boys try to take video clips with the help of mobile.

### **Conclusion:**

From above analysis it could be concluded that mobile is used for the purpose of harassment of adolescent girl students. The result also shows that on the one side adolescent girl students felt girls were harass by playing songs, taking pictures and video clips but personally they themselves not harass by these ways. This might be the insecure feelings among themselves. Adolescent girl students who realize that their photo or video clip is taken by boys but these girls can't stop such activity because of the fear of defaming in the school or college.
